A RESOLUTION BY MAYOR AND COUNCIL OF THE TOWN OF EASTOVER REQUESTING THAT SOUTH CAROLINA'S GENERAL ASSEMBLY SHOULD ACT TO REMOVE THE CONFEDERATE FLAG FROM THE STATEHOUSE AND THE HOUSE/SENATE CHAMBERS IN COLUMBIA, SOUTH CAROLINA

WHEREAS, the General Assembly of the State of South Carolina caused the Confederate flag to be flown over the Statehouse in Columbia as a part of the Centennial of the War between the States in 1962; and

WHEREAS, it was not the intent of the General Assembly at that time for the flag to remain atop the Statehouse after the Centennial celebration; and

WHEREAS, the Confederate flag is a symbol of the Confederate States of America, which was dissolved when the Army of Northern Virginia surrendered on April 9, 1865 ending the Civil War; and

WHEREAS, many citizens of the Town of Eastover view the Confederate flag flying over the Statehouse & Chambers as a symbol of racism, slavery and oppression; and

WHEREAS, this resolution is enacted with the hope of mending division which have become so pronounced, and bringing unity to our State, County and Town ; and

WHEREAS, removing the flag from the Statehouse would demonstrate and acknowledge that the only flags representing legitimate sovereign governments are the flags of the United States and State of South Carolina; and

WHEREAS, displaying the flag on a monument or in a museum would better serve the purpose of honoring those who fought and died;

NOW, THEREFORE BE IT RESOLVED, that the governing body of the Town of Eastover recommends to the General Assembly of this State that the Confederate flag on the Statehouse be placed in our State Historical Museum, where other memorabilia of our Civil War heritage and history are on display.

This Resolution shall be in full force and effect upon enactment. This Resolution shall be made available for inspection during normal business hours by the public at the Town of Eastover Administrative Building.

AN ORDINANCE TO AMEND ORDINANCE NUMBER ONE OF 1999, ENTITLED "AN ORDINANCE ADOPTING RULES OF ORDER," SO AS TO ADOPT AN ADDITIONAL SECTION THERETO PROVIDING THAT THE AGENDA OF EACH REGULAR TOWN COUNCIL MEETING SHALL INCLUDE AN OPPORTUNITY FOR EACH COUNCIL MEMBER TO RENDER A REPORT OF THEIR OFFICIAL ACTIVITIES.

Be it enacted by the Town Council of the Town of Eastover:

SECTION 1. Ordinance 1-1999 is amended by adding a new section to be numbered appropriately, which shall read:

There shall be standing committees of the Town Council with membership and responsibilities as follows:

"The agenda of each regular town Council meeting shall include an opportunity for each member of Council to report on their official activities. This report may be rendered orally or submitted in writing or both."

This Ordinance shall be in full force and effect immediately following its passage, approval and publication, as provided by law.

RESOLUTION ON HOW THE TOWN OF EASTOVER DESIRES TO
ALLOCATE ITS SHARE OF THE LOCAL OPTION 1% SALES AND USE TAX

WHERE AS, pursuant to Section 4-10-30 of the South Carolina Code of Laws, Richland County Council enacted an ordinance on July 21, 2004, which authorized a referendum to be held on November 2, 2004, on the question of whether the qualified electors of Richland County wished to adopt a one-percent sales and use tax that would be applied as a credit against the County and Municipal *ad valorem* tax liability; and

WHERE AS, the results of that referendum showed that the majority of electors favored the adoption of the sales and use tax; and

WHERE AS, the sales and use tax will be collected from merchants operating within the town of Eastover, and the subsequent credit applied toward the Town of Eastover's *ad valorem* tax liability;

BE IT RESOLVED AND DECALRED by Eastover Town Council that the Town of Eastover desires that the one-percent sales and use tax be allocated such that seventy-five per cent (75%) of said sales and use tax is applied as a credit against the County and Municipal *ad valerom* tax liability; and

BE IT FURTHER RESOLVED AND DECLARED that the Mayor of the Town of Eastover is hereby authorized to execute an agreement on behalf of the Town of Eastover memorializing the Town's intention and desire with regard to said allocation of the one-percent sales and use tax.
